What Have Been Your Early Steps or Thoughts on Infrastructure Development?

- Have you prioritized the areas for improvement from your infrastructure analysis?
- Where did you start and why (e.g., identification of key leverage points)?
- Is your SIMR baseline and targets based on statewide data or targeted for a smaller number of LEAs/programs with plans to scale up?
- What specific linkages with current initiatives have you identified or plan to explore?

Focus of Phase II: Plan

- Build state capacity to support LEAs/EI programs/EI providers with the implementation of evidence-based practices that will lead to measurable improvement in the SIMR
- Based on Phase I components, Phase II includes the activities, steps, and resources required to implement the coherent improvement strategies, with attention to the research on implementation, timelines for implementation, and measures needed to evaluate implementation and impact on the SIMR



Phase II: Plan Components

- Infrastructure Development
- Support for LEA/EI program/EI provider Implementation of Evidence-Based Practices
- Evaluation



Infrastructure Development From the Measurement Table

- Specify improvements that will be made to the state infrastructure to better support LEAs/EI programs/EI providers to implement and scale up evidence-based practices to improve the SIMR
- Identify the steps the state will take to further align and leverage current improvement plans and initiatives in the state, including general and special education improvement plans and initiatives/early learning initiatives, which affect children with disabilities



Infrastructure Development From the Measurement Table

- This section must also identify who will be in charge of implementing the changes to infrastructure, resources needed, expected outcomes, and timelines for completing improvement efforts.
- In addition, the state should specify how it will involve multiple offices within the state educational/lead agency, as well as other state agencies, in the improvement of its infrastructure.

From OSEP Review of Phase I

It was not always clear how States analyzed their infrastructure in relation to the SIMR

Changes that States would need to make within their own infrastructure to support LEAs/EIS programs in implementing evidence-based practices were not always included



From OSEP Review of Phase I

States did not report data specific to their infrastructure

In developing your Phase II SSIP, think about the changes that will need to be made within the State infrastructure and the type of data that is needed to enhance the infrastructure to support, improve, and sustain effective practice at the local level



From OSEP Review of Phase I

While States described other initiatives within the State, it was not always clear how the State would build off of these to meet the SIMR

In developing Phase II, consider how aligning with other initiatives can maximize impact, maintain momentum, and support sustainability



- How might you use/adjust each tool to fit your program and/or process?




ECTA Center System Framework



 - implementing improvement strategies





Corresponding Self-Assessment

- 1. Provides states a current status '**snap shot**' to help them prioritize improvement efforts
- 2. Quantitative self-assessment score provides states ability to **measure progress** over multiple points in time
- 3. Encourages state participants to engage in **rich conversations** about the system
