





High-quality data is timely, accurate, complete, usable, accessible, and secure


Working Principles of High-Quality Data



- 1. Timely—Data are current per a specific period of time
- Accurate—Data are reliable and valid
- 3. Complete—Data represent the expected population and subgroups
- 4. Usable—Decisionmakers can use the data
- 5. Accessible—Data are readily available in formats that are understandable, user-friendly, and practical
- Secure—Consideration is given for storage and maintaining confidentiality of data






